### New Business

#### 1. Strategic plan (attached)

##### a. Student consultation

- We must actively encourage people to participate in the survey soliciting student feedback
- Kristy, Matt, and Josh will be setting up a table to facilitate student discussions
- Town Hall on January 28<sup>th</sup> for students to talk about it
- Student awards, curriculum, RA positions should be pointed out to students
- A lot of the projects/goals are lofty and not concrete metrics
- This is a “to-do” list rather than a “to-accomplish” list
- This is still a very fluid process; the initial consultation resulted in the first draft – **but this is not the end (even if it’s not on the list, it does not mean that it’s not a priority)**
- **NB:** the Strategic Plan is something that will be shared with the world

##### b. Guests: Bruce MacDougall and Nikos Harris

##### **CONSIDER:**

- Broad-base admissions & discretionary category – concern that moving too far in the discretionary category would be a disservice to students (setting them up for failure)
- Enough ‘hard choices’? But everybody has their own particular “hard choices” that they want to have made. **We don’t have the time to make the hard choices at this time, rather it would be more appropriate to create a formal means of making hard choices.**
- **Project 2(a):** are there more specific metrics that should be achieved (first-generation university students, Vancouver communities, etc)
- **Project 3(g):** review should be more broad-based than just first-year
  - ➔ Students feel there should be more structure about what is expected of them (particularly in first year)
  - ➔ Expectations of students outside of the classroom – letters of reference, office hours, the summer program, etc
- Are professors expected to teach too much? Should professors have more leave?
- Hiring vs budget

##### **ALSS FEEDBACK**

- Curriculum review: no concrete metric – what would this look like?
  - ➔ What we’re teaching, what’s required, etc.
  - ➔ Class sizes
  - ➔ How many assignments? How is assessment conducted?
  - ➔ Size of ‘small groups’?
  - ➔ Course content?
  - ➔ Summer offerings? There is a general disappointment about how little is offered, particularly with increased clinic opportunities.
  - ➔ Online classes? Recording?

- Schedule overlap
  - Social Justice courses are missing
  - Ongoing formal evaluations of student satisfaction & curriculum (LESEE & student services)
    - ➔ Concern about standardization about the core courses
    - ➔ Lack of knowledge about what courses will entail in the upper years (workload, curriculum, etc)
  - There is a lot fewer supports for upper-years
  - **Project 2(a):** focus on young alumni
  - Improving on the concentrations – what do we want our specializations to be? (Environmental, social justice, feminism, etc)
  - Student funding
    - ➔ Professional student programs?
    - ➔ International students?
    - ➔ LLMCLs?
  - “Intro to law” course for 1Ls
